Rebecca Pauls is an enthusiastic leader and creative facilitator with a broad range of experiences in community development and collaboration with people who have disabilities. She is passionate about seeing the unique gifts each of person has, and is convinced that our communities will be stronger, safer and more resilient when each of us is contributing and recognized for our gifts.

As a mother to four children, Rebecca also has a deep appreciation for the roles that family and friends play in our lives, and is committed to connecting people with other people and places around them.

Rebecca is the Executive Director of Planned Lifetime Advocacy Network (PLAN), a Vancouver-based social enterprise that partners with families and people facing social isolation to secure their future by mobilizing relationships and leveraging community assets. Since joining PLAN six years ago, Rebecca has led a complete re-design of programming to integrate principles of person centred planning, ABCD, narrative therapy and independent facilitation. After demonstrating the strength and flexibility of this community approach, Rebecca is regularly invited to consult with organizations about how it can be scaled and applied to population groups across North America.

In a career that's taken her to communities across Canada and internationally to places such as Ethiopia, Zimbabwe and Guatemala, Rebecca has chosen to settle in Vancouver, British Columbia. She and her partner currently reside in the Gastown neighbourhood, a community known as a hub of social innovation and for its immense diversity.

Planned Lifetime Advocacy Network (PLAN) is family-led charitable organization dedicated to building inclusive communities for all citizens.

**PLAN** was founded in 1989 by parents who wanted to ensure their children could live a good life and contribute to their communities.

While our founders were initially focused on their children with disabilities, the five components we use to define a good life are universal – loving friends and family, a home of one's own, financial security, participating in decision making and the ability to contribute their unique gifts.

Like our founders, PLAN families are focussed on the best way to support sons and daughters who have disabilities. These courageous parents acknowledge that one day they will need to pass on their responsibilities to someone else. The question was, "Who?"

For those who have a child or a relative with a disability this question — "Who will take care of our children when we are gone?" is real and pressing. The families who founded PLAN searched and discovered solutions to securing the future for loved ones with disabilities.

Over time, the question changed from an 'after-we're-gone' focus and recognized that planning for the future changes the present. PLAN has evolved to find the many answers to: What does a good life look like for our relatives with disabilities?

Together with families and people with disabilities, we answer these questions by:

- building personal support networks that empower contribution and citizenship
- implementing plans to ensure loved ones with disabilities are safe and secure for their lifetime
- bringing together a network of families to provide mutual support and learning opportunities

Living with difference and vulnerability is challenging, yet L'Arche demonstrates that when all people, including the most marginalized, take their place, society becomes more human – more colourful, welcoming, creative, compassionate, and joyful.

The Vision of L'Arche is rooted in relationship and belonging:

- Mutual care, respect, and compassion between people with and without intellectual disabilities
- Sharing ordinary, daily life with all its joys and sorrows
- Living, working, learning, and celebrating together in communities of belonging
- Transforming our lives as we embrace our gifts and imperfections
- Recognizing that we need each other and are better together
- A model of inclusion, a way of peace, and a sign of hope for our world.

The L'Arche relational model breaks down barriers between those who give and those who receive supports. It replaces society's emphasis on independence that leaves so many people lonely, with interdependence where each person flourishes as they contribute their gifts for the good of others.
